



Whereas:

Hunger affected between 713 million and 757 million people in 2023, 152 million more than in 2019, before the pandemic;

The prevalence of undernourishment in the world is estimated at 9.1%, of which approximately 41 million people are in Latin America and the Caribbean;

Around 133.4 million people in Latin America and the Caribbean, about 22.7 per cent of the population, do not have access to a healthy diet, and the region has the highest cost of purchasing healthy food;

About 2 billion people are overweight or obese due to poor diets and sedentary lifestyles, and 27.3 per cent of adults in Latin America and the Caribbean are obese;

Climate change is having a gradual and significant impact on food production and costs, further reducing access to sufficient and healthy food;

Rising food prices, especially for fresh food, encourage the consumption of cheaper diets of poor nutritional quality;

The structural problems of inequality, labour informality and poverty in the region were exacerbated by the pandemic. One of the main consequences was the closure of schools during this period, affecting some 167 million students in Latin America and the Caribbean, and affecting the provision of school meals to these students, who often relied on school meals as their main source of daily nutrition.

The provision of food at school is a social strategy that helps to address crises of all kinds - social, economic, environmental and health, as it is an effective tool for the achievement of the human right to adequate and healthy food;



PFSs work to meet global impact goals such as the Sustainable Development Goals (SDGs), especially SDGs 1 (end poverty), 2 (zero hunger), 3 (health and well-being), 4 (quality education), 5 (gender equality), 10 (reducing inequalities), 12 (responsible production and consumption) and 17 (partnerships to achieve the goals), among others.




